



GHRA 2025 Stallion Service Auction

Guideline for Buyers

Thank you for participating in our inaugural stallion service auction to support the annual North American Championship show and the GHRA futurity program. Stallions participating in the auction must be GHRA registered for complimentary futurity enrollment. GHRA registered stallions will be automatically enrolled in the GHRA futurity program for 2025. The resulting 2026 progeny will be eligible for nomination into the program.

Terms & Conditions:

1. You must register to bid at <https://www.32auctions.com/ghraauction25>. Registering, Bidding and/or winning means you agree to the terms & conditions of this auction.
2. Only bids from the designated auction site will be accepted. The highest bid at the close of the auction will be the winner.
3. This stallion service auction is available only to individuals who can enter into legally binding contracts and are a minimum 18 years of age.
4. Bidder acknowledges auction is conducted through an online service. GHRA is not responsible for hardware or software malfunctions that may occur without warning.
5. Submission of a bid is a binding offer.
6. All transactions are in US Dollars and will incur a 3% processing fee.
7. You can bid on multiple items during the auction.
8. The starting bid for each stallion will be 25% of their normal service fee and bidding will increase in increments of \$50.

Stallion owner/manager:

1. Stallion owner reserves the right to approve or refuse the mare being offered. Please contact stallion owner in advance for approval before bidding.
2. The guidelines set forth in the stallion's service contract will be the binding agreement between the mare owner and the stallion owner/manager. GHRA will not participate or act as mediator in contract disagreements between mare owner and stallion owner.
3. If a stallion is sold with pending service, it is the responsibility of the stallion owner to reach an agreement prior to the stallion changing ownership. GHRA will not participate or act as mediator in negotiation.
4. Upon the conclusion of the auction, stallion services that have not been sold will be offered at 50% of their stated fee with the same rules and obligations stated.
5. Stallions participating in the auction must be GHRA registered for complimentary futurity enrollment.

Buyer and/or mare owner:

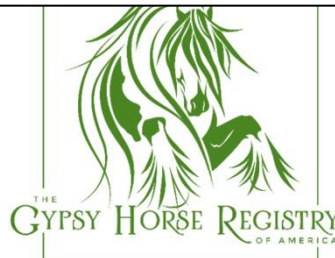
1. It is the buyer's responsibility to obtain the necessary information about the stallion in this auction as it pertains to health, disease, genetics, temperament, etc. prior to entering a bid.

2. It is the buyer's responsibility to fully understand all fees outside of the bid price, including but not limited to, chute fee, booking fee, shipping fee, boarding fee and any other applicable fees to the breeding process.
3. When auction concludes, the winning buyer has 48 hours to submit payment in full. If payment is not made in 48 hours, the service will be sold to the next highest bidder (with the same requirement). Payment type accepted, debit card, credit card, paypal or wire transfer.
4. A breeder's certificate shall be furnished by the stallion owner to the mare owner upon payment of full of any fees owed and the birth of a live foal.

Liabilities and Guarantees

1. All breeding services are sold as is, where is, with no warranty expressed or implied. GHRA makes no guarantee as to the quality or outcome of the breeding. GHRA does not guarantee a successful breeding and/or a viable foal.
2. GHRA is not liable for any damages or injury sustained or claimed by any person connected with this auction.
3. GHRA is not responsible for any other business conducted between the stallion owner/manager or the breeding facility/staff and the winning bidder. GHRA is not responsible for any claims or statements made by the stallion owner/manager, mare owner/manager or breeding facility and its staff.
4. GHRA does not assume liability for any disputes between the mare owner and stallion owner.
5. If a stallion should die or become unfit for breeding, it is the responsibility of the stallion owner and the mare owner to come to an agreeable resolution. GHRA will not participate or act as mediator in negotiations. Should the stallion's contract provide terms to the mare owner a refund, then GHRA will issue a refund for the amount of the winning bid. A statement from a licensed veterinarian will be required before any refunds are issued.

Terms:

1. Breeding sells under the terms expressed in the stallion’s 2025 contract which will be provided by the stallion owner/manager to the buyer upon notification of buyer payment received.
2. Stallion owner/manager will provide a copy of stallion’s 2025 contract to GHRA.
3. Participation in the GHRA auction grants GHRA the right to sell one breeding of your stallion.
4. Breeding purchased through this auction may not be sold or transferred without written permission from the stallion owner/manager.
5. Stallion owner reserves the right to approve or refuse service to the mare offered. It is the buyer’s responsibility to contact stallion owner/manager prior to bidding for approval.
6. Upon conclusion of the auction, unsold services will be offered at 50% of the stated fee.
7. Stallion owner/manager agrees to provide the mare owner a breeder’s certificate upon payment in full for all fees and birth of a live foal.

In the event the stallion dies or becomes unfit to breed and the stallion’s contract provides the mare owner a refund, then GHRA will issue a refund for the amount of the winning bid. Statement from a licensed veterinarian will be required before refund is issued.

If a stallion is sold with pending service, it is the responsibility of the stallion owner to reach an agreement prior to the stallion changing ownership. GHRA will not participate or act as mediator in negotiation

GHRA is an agent in this sale and is not responsible for any accident, sickness or death of stallion, mare and/or foal. GHRA will not participate or act as mediator in contract disagreements between mare owner and stallion owner/manager.

Donation Terms
